Note:

- (a) The empanelled candidates will remain on probation for a period of two years.
- (b) The confirmation and retention of the candidates as regular employees will be subject to their performance in the relevant field being satisfactory.
- (c) On completion of two years probation period, the performance of the candidates as Sports person will be reviewed by a review committee and if their performance as Sports person is considered unsatisfactory by the said committee their services will be terminated by observing requisite procedure.

- (d) The candidates have to execute a Service Bond (as per specimen to be enclosed with offer of appointment) before joining to the railway to the effect that they will serve the railway for a minimum period of 3 (three) years and in case of infringement/violation of this Service Bond they are liable to pay an amount equal to 3(three) years salary before severing connection with the Railway.
- (e) The empanelled candidates will be issued offer of appointment after satisfactory verification of their testimonials/certificates.
- (f) The Railway administration reserves the right to cancel the candidature of any candidate empanelled at any time during his service period if the particulars submitted by the candidate in his application are found to be false.
- (g) It is made distinctly clear that the mere fact of a candidate being empanelled will not confer upon him any claim or right for employment and this is subject to the production of relevant original documents with regard to Caste, Date of birth, Educational qualification, Sports qualification etc. and any fraudulence in this respect will be taken up as per extant rules.
- (h) The above named approved candidates will be posted as per their turn in Group-'C' and Group-'D' categories respectively subject to availability of vacancy and subject to passing requisite Medical Examination in the required category.
