EMPLOYMENT NOTICE NO.2/2007 – Med/Doc/CMP

WALK-IN -INTERVIEW

(A) Notice

East Coast Railway desires to engage 07 nos. full time medical practitioners on contract basis (CMP) for a duration of one year. The places of posting are within the geographical jurisdiction of East Coast Railway, Bhubaneswar and is further detailed as under. Thus 'walk-in' interview will be conducted at Rail Vihar, Chandrasekharpur, Bhubaneswar-23 for Indian citizens for engagement as full time **General duty Doctor –CMP** on contract basis on payment of honorarium for a period of one year or till **regular 'UPSC Doctor' is available** whichever is earlier. The provision of monthly remuneration for the General Duty full time Contract Doctor (CMP) and their daily rate basis proportionate deduction from their honorarium fee/remuneration in the event of such Contract Doctor-CMP absenting himself/herself for the period exceeding from those stipulated in the contract is existing. The remuneration to CMP (Contract Medical Practitioner) may be at following rates -

(B) REMUNERATION

- i) Monthly fees Rs. 21,900/-(consolidated with HRA) for full time General Duty Doctor-CMP.
- ii) Daily rate of deduction from the fee for excess absence may be Rs. 730/-(approx) per day from General Duty Doctor -CMP

Full time CMPs (Contract Medical Practitioners) may be provided unfurnished railway quarter accommodation subject to availability. In case Railway accommodation is provided to the CMP, an amount equivalent to HRA and license fees of the accommodation so provided shall be deducted from the monthly fees admissible to CMP. The General Duty Doctor- CMPs so engaged will be posted anywhere in East Coast Railway subject to the decision of the competent authority at the material time depending upon the vacancy position.

(C) VACANCY

Total no. of vacancies – 07 (SC=01, OBC=02, UR=04)-General Duty Doctors

- N.B :-
1. The vacancies are interchangeable and adjustable and may increase or decrease along with reservation roster as per administrative necessity. There may be 'wait-listed' CMPs also against the notified / select list who may be engaged as per necessity.
 2. The place of vacancies are liable to change depending upon joining of regular ADMOs from UPSC panels.
 3. The vacancies of General Duty CMPs are at the geographical jurisdiction of Sambalpur Division, Waltair Division of East Coast Railway and the stations are Titlagarh, Kirandul, Araku, Marripalemm and Waltair.

D). Educational Qualification/Eligibility

- a) General Duty Doctor (CMP)- The candidate should be minimum MBBS pass and with registration in Indian Medical Council or in possession of valid registration certificate of any of the State Medical Councils of India after completion of one year compulsory, rotatory internship.

E). Age – Not exceeding 60 years of age as on 01.09.2007. However age relaxation is admissible for 5 years to candidate from SC/ST community and 3 years for OBC community candidates.

F) Other terms & conditions

- 1) Selected candidates will be subjected to medical examination and only medically fit candidate will be given the award of contract/engagement as CMP.
- 2) The full time Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
- 3) During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other grounds by giving prior 30 days notice to the Railways.
- 4) The services of these CMPs are also terminable before the expiry of one year by either side after giving 14 days notice or on payment of 14 days of honorarium in lieu of the same.
- 5) The engagement as contract doctors is a stop gap arrangement and will not count as service in case of regular selection through the UPSC.
- 6) It will not confer any right for automatic regularization or absorption in railways.
- 7) No private practice is allowed.
- 8) The detailed instructions with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection alongwith the offer of engagement and contract (with terms and conditions in detail).
- 9) The contract shall also be terminated by the Railways administration if the CMP is found to be mentally or physically incapacitated.
- 10) The administration of the ECoR reserves absolute rights to cancel this notification without assigning any reason(s).
- 11) Appearance in the interview will not vest any right upon the candidate to be engaged as CMP & no reasons will be cited or communication shall be made with the candidate in the event of candidate not getting selected.

On the prescribed days of '**Walk-in interview**' the eligible and willing candidates should report to the Authorised Representative of East Coast Railway in the office of CPO/East Coast Railway/Chandrasekharpur/Bhubaneswar alongwith the application form duly filled in the format appended below and enclosing necessary attested copies of the testimonials (attested by Gaz Officer), two passport size photographs at the venue of the Interview in time. Original certificate(s) should be produced for verification at the time of interview. **The day(s) of interview may be more than one day and no TA/DA/Accommodation will be provided to the candidates attending the interview.** Reserved community (SC/ST)and, OBC category of candidates should bring their latest caste certificate (attested copy and original both) issued by the Competent Authority in the prescribed format.
